Case Scenario

A 52-year-old patient is referred for ongoing bleeding and mobility affecting posterior teeth. They report tooth sensitivity and "getting food stuck" interproximally. Their Medical history includes type 2 diabetes (recent A1C unknown), controlled hypertension. They are a former smoker (quit 1 year ago). The patient had intermittent dental care and multiple large posterior restorations.

Candidates may be provided with the following supplementary records for interpretation:

- Intraoral photographs
- Extraoral photographs
- Radiographs
- Periodontal Charting



Data Gathering, Etiology & Diagnosis

Question: From the provided records, summarize the key clinical and radiographic findings and synthesize a working diagnosis.

Proficient response demonstrates:

- Accurate selection of salient findings
- Internally consistent diagnosis using contemporary classification, with rationale tied to the observed findings

Question: What uncertainties remain, and what additional information or investigations would most influence your diagnosis?

Proficient response demonstrates:

- Clear statement of diagnostic limits and justified indications for further data
- A plan to reconcile conflicting findings and refine the diagnosis.

Prognosis, Treatment Planning & Management

Question: State your prioritized problem list and primary treatment objectives, then outline two viable treatment pathways.

Proficient response demonstrates:

- Concise, prioritized problems linked to measurable objectives
- Evidence-based options with indications/limitations and anticipated trade-offs; alignment with medical status/behaviours and restorability.

Question: Specify your initial plan and sequencing including criteria to adapt the plan.

Proficient response demonstrates:

- Logical sequencing that incorporates risk factor control, local and/or systemic adjuncts as appropriate, and clear re-evaluation criteria.
- Defined thresholds for referral/interdisciplinary coordination



Post-Treatment Management & Maintenance

Question: What outcomes will you monitor after initial therapy and how will these guide maintenance interval and further care?

Proficient response demonstrates:

- Objective parameters for healing and response.
- Individualized maintenance plan tied to risk and response, with transparent criteria for modifying intervals and re-treatment.

Question: List important post-treatment complications you will watch for and outline your management approach.

Proficient response demonstrates:

- Vigilance for biologic/mechanical complications and early, proportionate responses plus safety-netting instructions.
- Recognition of failed/unsuccessful treatments and formulation of alternative options where appropriate.

Communication

Candidates are assessed on communication holistically throughout the case.

Proficient response demonstrates:

- Communicates answers directly, clearly, and logically.
- Articulates reasoning clearly, concisely, and in a well-organized manner; remains relevant and uses appropriate terminology.
